Observations & Findings:


During the inspection, team found space for infrastructural and instructional facilities to grant extension for provisional affiliation of BBA & BCA courses with intake capacity of 60 seats in each course.


Suggestions:

1. The Divine Institute of Management & Studies, Ziradei, District-Siwan, Bihar – 841245 authority is suggested to appoint Faculty Members maintaining cadre ratio as per AICTE norms before the commencement of the classes.
2. More relevant books & journals/E-Journals are required to be available in the Library.
3. Provisions to watch MOOCS Course (s) through Swayam.
4. More Smart Classes are required.
5. Need to be upgrade of computer hardware and licensed software in lab & library.
6. Wi-Fi Facility is required to be strengthened.

Recommendations:

On the basis of observations and findings, the extension for provisional affiliation may be granted to the Divine Institute of Management & Studies, Ziradei, District - Siwan, Bihar – 841245 for BBA & BCA courses with intake capacity 60 seats (Sixty seats) in each course effective for the academic session 2024-25.
